V Principal's Report

- ❖ Students have been adapting to the frigid weather and having to stay in for recess.
 - ❖ Mrs. Messier is settling in to her new 4th & 5th grade teacher role very well.
 - ❖ Holland had a successful musical jamboree on the 24th, about 90 people attended.
 - ❖ 4th & 5th grade students prepared parsnips through Farm-To-School learning and then served it to their peers during lunch one day.
 - ❖ Teachers have begun a writing workshop, school-wide, to assess students on the understanding of nonfiction writing. This will be a collaborative assessment so all teachers are scoring the same way.
 - ❖ Nancy Woods continues to support teachers through Vermont Reads
 - ❖ Air Handler work will be completed during February break
 - ❖ The second dialer panel was installed
- Kelli added that there have been some fowl odors in the K-1 classroom. This has been something that comes and goes and sometimes smells in the 6th grade classroom as well. Kelli recalls smelling it last year as well and has asked a few different service providers (that were at the school providing other services) what they thought it could be. Fred's Plumbing & Heating suggested that we open the wall in the bathroom, where the odor is the strongest, to assess the problem. Until then, Kelli will not know what services are needed for repair. At this time she is waiting for a call back from Mark Fuller about the asbestos check to be sure it ok. Any work needed will be provided during school break. The Board supports Kelli in this process.

VI Superintendent's Report

- John expressed to the Board that he is trying to align monthly board meetings throughout the district a little more efficiently for his schedule. He and other supervisory staff are having trouble making it to some school board meetings due to scheduling conflicts. Sometimes meetings overlap one another and are not in adjacent towns, so he struggles to make them in time. The Board supports this and will try and adapt as needed. John said he would make a potential schedule and go from there. John is always helpful and supportive of Holland School and the Board appreciates and welcomes him when he can attend.
- John would like Boards to discuss approving the hiring of Support Staff and Para-educators to the in school principal and Superintendent. While he realizes that this could become a trust issue he wanted to assure the Board that it would speed up the process of hiring and that the Board would still be informed of what was going on. The only change would be that the Board wouldn't need to approve the hiring at the Board Meeting.
