H. The Chronicle and The Newport Daily Express were designated as official newspapers.

I. The Westfield General Store, Westfield Town Clerk's Office and Westfield Recycling Center were designated Posting locations.

J. Regular meeting dates and times were established as the second Tuesday of the month, as needed, directly following the Jay/Westfield meeting.

K. The Board Code of Ethics were reviewed, approved and signed.

III. Kevin Amyot moved to approve the Minutes of February 9, 2016. Motioned carried.
